Resource Net Script

November, 2010

Preamble (announce frequently)

THIS IS [GIVE YOUR FCC CALL or WC5GC], GRAYSON COUNTY ARES [RACES] RESOURCE NET CONTROL.

THIS [FREQUENCY/REPEATER] IS ACTIVATED FOR [AN INCIDENT/A DRILL].

[THIS IS A DRILL. THIS IS A DRILL.] / [THIS IS NOT A DRILL. THIS IS NOT A DRILL.]

GRAYSON COUNTY AMATEUR RADIO EMERGENCY SERVICES [RACES]

REQUESTS EXCLUSIVE USE OF THIS FREQUENCY FOR THE DURATION OF THIS EVENT. THIS IS A CONTROLLED NET FOR [EMERGENCY/DRILL] OPERATIONS WITH ASSIGNED OPERATORS. ALL COMMUNICATIONS ARE TO BE ADDRESSED THROUGH NET CONTROL. USE NET EMERGENCY CONVENTIONS AND KEEP TRANSMISSIONS SHORT.

IF YOU HAVE **NOT** BEEN ASSIGNED FOR OPERATIONS, PLEASE CHECK INTO THIS NET TO RECEIVE AN ASSIGNMENT AND PRELIMINARY RESOURCE TYPING.

THE PRESENT STATUS OF GRAYSON COUNTY AMATEUR RADIO EMERGENCY SERVICES ACTIVATION IS

[LEVEL !GREEN! — INACTIVE]

[LEVEL !YELLOW! — ALERT STATUS]

[LEVEL !ORANGE! — STAND BY STATUS FOR DEPLOYMENT WITHIN THE NEXT FILL IN TIME HOURS/MINUTES]

[LEVEL !RED! — FULL DEPLOYMENT STATUS].

Preliminary Resource typing

I WILL NOW CHECK STATIONS IN ONE AT A TIME. WHEN YOU CHECK IN, PLEASE GIVE YOUR FULL CALL AND, IF YOU KNOW YOUR COMMUNICATIONS RESOURCE FUNCTION (CRF) TYPE FROM THE GO KIT CHECKLIST, PLEASE GIVE THAT WHEN YOU CHECK IN.

GRAYSON COUNTY ARES SOP-2

ID frequently, at least every 10 minutes

[End each transmission with the FCC legal call sign or WC5GC or K5GCC?.]

Station Check-in

[Stations call as they arrive on station. Simply acknowledge and log their entry time, etc.]

[You should use the FCC call of the other station.]

Station Roll Call

[At least once every 30 minutes or more often if not busy]

[Call all stations on the log using their FCC call.]
